COAT National Conference Ballot is OPEN

The 2024 COAT National Conference which will be hosted as a hybrid in-person and online event on 6-7 June 2024, in Brisbane.

The COAT SA Committee has agreed to provide financial assistance to up to three COAT SA Members for:

- the cost of **two** early bird online registrations (the value of \$500 per registration)
- the cost of **one** early bird in-person registration with dinner (the value of \$850)*

**The cost of registration is not inclusive of travel and accommodation.*

The Committee will give preference to applicants who have not received financial assistance to attend the conference in either 2023 or 2022.

By submitting an application, the applicant agrees that if they are employed by a Tribunal which is also providing financial support to its members to attend, and the applicant receives such assistance from that Tribunal, then the applicant will relinquish the financial assistance which would otherwise have been provided by COATSA.

The Committee has a discretion as to the selection of applicants to whom financial assistance will be provided. If an applicant has a particular reason for wishing to attend the conference, the applicant should mention that in their request.

The Committee would like successful applicants to provide a brief summary of some aspect of the conference which they found particularly useful or interesting, for us to include in our newsletter.
